### 2012 Variety Comparison Plot Rules

#### Corn (Two plots)

1. Each participating company is invited to submit two hybrids for entry in the plot. One hybrid will be planted on soybean ground and one will be planted on chiseled corn ground. It is in your best interest to provide a triple stack hybrid. Both plots will be treated with glyphosate, and neither plot will receive a soil applied insecticide.
2. Each company shall list the maturity of each hybrid in heat units.
3. Each company shall list seed size or recommended JD vacuum settings.
4. Each company shall provide at least ONE UNIT of seed of 40 lbs. or more and contain a minimum of 80,000 seeds.
5. Each hybrid must be available for purchase in quantity to farmers in Kane County (no experimentals).
6. All varieties must have full USDA, FDA, and EPA approval at time of planting.
7. All varieties must be accepted for delivery to Elburn Coop at time of planting.
8. Each company shall send \$100.00 to be entered along with entry form.
9. The winner of each plot will have the opportunity to provide the 2013 check and will have no entry fee for that particular plot.

#### Please note:

- Entry fees will be used to provide a field day and for publishing and distributing plot results.
- There will be no soybean variety plot for 2012. Soybeans will be grown for other test plot purposes this year.
